The project started with police statistics for Cyprus, analysed the last two years (1994 - 1995)

Then some reference was made on road geometry, as a factor leading to safety problems.

Then, the project proceeded with introducing measures for the reduction of fatal and serious accidents.

Also, some measures for enlightenment of the people were introduced, for reducing the number of traffic accidents. All these measures were suggested for the better prevention of accidents.
