## **SUMMARY**

The purpose of this system is to create a computerized information system for clubs and societies in a tertiary educational establishment.

For this reason, a computerized system is developed to handle all this time consuming and make the overall operations of a club or society more efficient.

It covers all the needs of a club or society in terms of forms, reports, statistics and graphs.
